By this time, I am sure many members of the community have seen the YouTube video posted numerous times on our social media pages. The video suggests that a Lyon County Deputy stopped a pedestrian on a bicycle and began berating him with foul language and fabricated an arrest. The video posted on YouTube does not give a complete depiction of what took place on September 14th, 2023.

The incident began when our Deputy responded to what appeared to be an open or uncontrolled fire near an apartment building. The flames were estimated to be 7-10 feet tall, and it appeared the building maybe on fire. As the Deputy attempted to inquire about the large flames, he observed, a male subject in a black hooded sweatshirt leaving the immediate area on a bicycle, around the rear of the apartment building. The address the Deputy responded to is an area known to be a high crime area, as the Sheriff's Office is consistently dispatched to the area for various criminal investigations/complaints. Sheriff's Office records indicate 150 calls for service have been generated from this area, and more specifically 80 calls for service for various criminal complaints have been generated by the known permanent residents of the living quarters the Deputy responded to.

The residents who were contacted were asked who was leaving on the bicycle, which they indicated, they "did not know." This was unlikely as the subject had been in the area of the fire in front of the apartment building as the Deputy initially approached.

The Deputy returned to his patrol vehicle and drove around into the parking lot shared another complex, in an attempt to locate the subject based on his obvious flight from a high crime area upon the arrival/sight of law enforcement.

The Deputy located the subject now pushing his bicycle into a patio area of a four unit building, which he thought the subject may be attempting to hide. He exited his vehicle and called out to the subject to “come here”. Upon turning around, the Deputy recognized the subject as JAMES GRESHAM from prior law enforcement contacts. He instructed GRESHAM to come to him, which he initially complied but was agitated and yelling at him, stating he did nothing wrong.

GRESHAM is known to have a history of resisting and obstructing law enforcement, as well the suspect of a multitude of crimes committed in Fernley.

Several renditions of the video start at the contact with GRESHAM pushing his bike.

I have made it clear, to my Deputies and to the Community, that the Lyon County Sheriff's Office will aggressively pursue those that choose a life of crime over our quality of life. Our Deputy was acting within

the mission and direction that I want all of our Deputies to abide by. Was there foul language used? Absolutely. The Lyon County Sheriff's Office expects our Deputies to act professional at all times, there is a time and a place for such language to gain compliance from a suspect. The Deputy in the video knows this as well, and acts accordingly. Had this Deputy responded this way to a community member who doesn't live a life of crime, this press release would read different. If the Lyon County communities take issue with the way our Deputy acted, I take full responsibility, as this is the direction I have given them.
