LCSO continues investigation into man missing for more than two years

The Lyon County Sheriff's Office continues to investigate the disappearance of Ronald Littleley, a 56-year-old man who was reported missing in September 2022.

Littleley was last known to be living at a home on Dixie Lane in Fernley. He was last seen in mid-September 2022. A welfare check conducted on Sept. 22, 2022, determined that Littleley was not at the home on Dixie Lane, and he has not been seen or heard from since that time. His personal belongings, including his vehicles, were at the home and he is believed to have left the area on foot.

Because of concerns related to Littleley's medical and mental health history, he was entered into the National Crime Information Center (NCIC) as an endangered missing person. Since the initial report, deputies and detectives have conducted follow-up checks, neighborhood canvasses, and coordination with family members and partner agencies. Despite these efforts, no confirmed sightings or leads have

been developed.

The investigation into Littleley's disappearance remains open and active.

The Lyon County Sheriff's Office said a body found Jan. 7, 2025 in a wooded area south of Farm District Road and U.S. 50A was not Littleley, but no positive identification on that body has been made.

As of January 2026, Ronald Littleley was listed on the National Missing and Unidentified Persons System (NamUs) with the following link: <http://www.namus.gov/MissingPersons/Case#/153841>

Littleley is described as a White male, born Sept. 10, 1969, approximately 6,1" and 185 pounds.

The Lyon County Sheriff's Office is asking anyone with information regarding the whereabouts of Ronald Littleley, or who may have seen him since September 2022, to contact law enforcement. Tips may be provided anonymously.

Torres updates Rotary Club on city projects

Fernley City Councilman Albert Torres gave the the Rotary Club of Fernley a brief overview of some of the council's work over the past year and some of the major issues ahead at the Club's Jan 5 meeting.

Torres was appointed to the council in August 2019 following the resignation of Sue Seidl, who moved out of the area. He won election to the seat in 2020 and was reelected in 2024.

Water and sewer facility upgrades were among the topics Torres highlighted. In August, the council voted to move forward with planning for water and sewer treatment improvements. The city's current sewer treatment facility is not capable of reducing nitrogen, a consultant told the council. The city wants

to upgrade the quality of the effluent leaving the sewer treatment plant, to be able to sell it to industrial users or for irrigation. Torres said the proposed site is an 80 acre parcel directly north of the existing facility, which is east of the industrial park along Newlands Drive.

Torres said the goal is to complete the project by 2030, calling that timeline realistic.

The estimated cost is \$50–55 million, most of which the city expects to cover through grants.

"This is the only project, and I'm speaking only for myself as far as council here, the only project where I would say yes to bonding, because it's that important," Torres said.

Regarding water, three of Fernley's monitoring wells have PFA, or polyfluoroalkyl substances, levels slightly above

the 4 parts per trillion recommended by the Environmental Protection Agency (EPA).

Torres said PFAS contamination is a nationwide issue.

"Almost every single entity across the country has PFAS in their water," he said, noting it is often a by product of piping and lining materials used in water treatment and distribution.

He said Fernley's water remains among the cleanest in Nevada. The city is adding filtration systems and replacing aging components, largely funded through the water and sewer enterprise fund. He said the city is working working with the U.S. Economic Development Administration on grant funding for upgrades to the water treatment plant.


Torres discussed the city's first Spe-

cial Assessment District, created last year for Nevada Pacific Parkway, and the ongoing study of potential impact fees.

Developers, he said, have increasingly asked why Fernley lacked SADs or impact fees, prompting the city to begin evaluating both tools.

Once the extension of Nevada Pacific Parkway is completed, Torres said NDOT will assume responsibility for Nevada Pacific Parkway because the city lacks the expertise and equipment to maintain bridges. In exchange, Fernley will take over Farm District Road, and Torres said he hopes improvements to Farm District, Road, including the extended bike path and crosswalks with flashing lights, will be complete.



Waiting for the council's city manager decision


Some weeks, the news cooperates with the deadline. This week isn't one of them. As I write this while trying to beat our Tuesday deadline, the Fernley City Council hadn't yet met on Wednesday night to interview the two remaining candidates for the city manager's position.

By the time you read it, the council will have made its choice, or decided it doesn't have one.

The council was originally supposed to interview four finalists, but one withdrew a couple of weeks ago, and a second one stepped aside last week. Will the council decide it likes one of these last two enough to hire one, or will it decide to start the search over again?

If that sounds familiar, it should. That's what happened in 2023, the last time the city was looking for a manager. The council voted not to hire either of the candidates the first round of recruitment produced, before hiring Ben Marchant after a second round of recruitment.

The resignation of Marchant last May during a very contentious budget session and the subsequent disharmony among the City Council brings into question, exactly how attractive is the Fernley City Manager position? What kind of candidate looks at the recent turbulence and says "Yes, that's the

challenge I want?"

The candidate who says that, who looks at the turbulence, the turnover, the political friction, and still raises a hand, is exactly the kind of candidate the city needs. Wednesday's meeting will tell us whether the council thinks one of the two finalists is that person, or whether they still need to keep looking.

There was apparently no shortage of interest in the position. Mayor Neal McIntyre told the council that 92 candidates applied, although he said the consulting firm whittled that down to 14 "viable" candidates, before the committee chosen by McIntyre came up with four finalists.

In the end, the number of applicants matters far less than

finding the right candidate. Fernley doesn't need someone who is impressed by the title, it needs someone who understands the weight of the work and is willing to shoulder it. The council's choice will tell us whether they think that person is in the room, or still somewhere out there waiting to be found.

'Water Masters' documentary highlights local water issues

As population growth and industrial needs increase the demand for water, researchers at the College of Engineering's Nevada Center for Water Resiliency (NCWR) seek solutions. The issues are highlighted in a new 30-minute documentary, "Water Masters," which premiered in December at the University of Nevada, Reno.

Produced by Emmy-winning di-

rector Dan Druhora, "Water Masters" explores water use along the Truckee River Watershed, the water system connecting Lake Tahoe to Pyramid Lake. The film examines the concept of upstream and downstream users, highlighting how population growth and the expansion of industry, such as new data centers that require water for cooling, increase water needs.

"I think what I would like people to take from 'Water Masters' is just how

important water is, and how precious it is," NCWR director Sage Hiibel said.

Established in 2023 with a grant from the U.S. Army Engineer Research and Development Center (ERDC), the NCWR researches and tests new technologies in water treatment, focusing on non-potable (drinking) water reclaimed from a variety of water resources. Hiibel, a chemical engineering associate professor, focuses on water reuse in the industrial sector, while

other NCWR researchers address such topics as advanced water treatment or the quantification and characterization of emerging contaminants.

"Water Masters" is the third in a four-part documentary series, "Flowing Forward," which explores water research at the University of Southern California, University of Arizona and the Army ERDC. View it on Vimeo: <https://vimeo.com/1129685525?fl=pl&fe=cm>

Keller announces re-election campaign for Lyon County Commission, District 2

Lyon County Commissioner Scott Keller announced that he will seek re-election for a second term for the District 2 seat on the Lyon County Commission.

Keller was elected to represent District 2 in 2022, which covers part of Fernley and part of Silver Springs. He served as the commission chairman in 2025.

The filing period for candidates running for office is from March 2-13.

In announcing his candidacy for a second term, Keller cited his commitment to practical leadership, responsible growth, and securing resources that strengthen Lyon County's communities.

Since taking office in 2023, Keller said he has focused on the fundamentals that matter most to residents, public safety, emergency preparedness, infrastructure, and essential services, while maintaining a steady, fiscally responsible approach to county government.

"Lyon County deserves leadership that's focused on results, not rhetoric," Keller said. "Over the past term, we've worked to bring outside dollars home, improve coordination during emer-

Sheriff's Office warns of scammers impersonating officers

The Lyon County Sheriff's Office is warning the public of a scam where a caller claiming to be a Lyon County officer is calling to collect money and leaving messages referring to legal matters.

The Sheriff's office said Lyon County Dispatch has been receiving calls from residents reporting the scams. In some of the most recent calls, the caller has used the name Sergeant Murray.

Previously, the Sheriff's warned of

a scam where a caller impersonating Sheriff's Office sergeants contacted family members of people who had recently been arrested, claiming that money was needed to post bail or to cover jail-related programs. The Sheriff's Office said those callers typically demanded payment through gift cards or mobile payment apps.

The Sheriff's Office says it would never call and ask for money or personal identification over the phone and is advising residents not to respond to the scammers.

The Powerful Tools for Caregivers program gives you the skills to take care of yourself while caring for someone else. By taking care of your own health and well-being, you become a better caregiver.


Lyon County Human Services uses PTC curriculum to provide support

McHoppers's expansion adds games, event space

For years, one thing McHoppers Brew Co. owners Mike McMordie and Dody Hopper heard over and over is that there's nothing to do in Fernley.

That's one reason they opened the brewery in September 2021, and now have tripled its space with games and an event venue that they hope will make the brewery a true Fernley destination.

After the Boys & Girls Club moved into the new Community Response and Resource Center in September, McHoppers took over their former space next door to the brewery, adding 4,800 square feet and bringing the total space to about 7,200 square feet. The remodel created 2,100 square feet of reservable event space and 2,700 square feet of new gaming space, including four lanes of axe throwing, two cart boards, a kid zone and three tournament grade Diamond pool tables.

"We're not just a brewery anymore," McMordie said. "We wanted to build something Fernley didn't have."

The new event room can seat up to 120 people at tables or up to 220 in stadium style seating. The space was intentionally designed as a blank slate, with movable staging, adjustable lighting and a planned drop down projector for business meetings or seminars.

Since opening, it has already hosted a wedding, an engagement party and a New Year's Eve celebration.

"It's perfect for an event between 60 and 100 people," McMordie said.

McHoppers does not provide catering but can recommend caterers if customers need it. Guest may also arrange their own catering, and McHoppers offers several alcohol service packages to choose from. The brewery recently expanded its license to allow full liquor service for private events. Spanish and English speaking DJs are available for hire.

"For the first 10 parties booked, we're offering free table and chair rental," McMordie said.

Axe throwing costs \$20 for 30 minutes or \$30 for an hour per person, for ages 12 and up with a parent. Pool

leagues are already lining up and will play Mondays and Wednesdays, with another league expected on Thursdays. The tables are open to the public Friday through Sunday.

With the added space, McHoppers has extended its hours and will expand its food menu by the end of January to include wings and fries alongside its paninis. The new hours are 2-10 p.m. Monday, Wednesday, Thursday and Saturday, 2 p.m.-12 a.m. Friday and 1-6 p.m. Sunday.

Children are allowed in the brewery portion until 6 p.m.

McHoppers continues to host karaoke, trivia nights and its regular open mic nights with the Fernley ACES, as well as bingo fundraisers one Wednesday per month, which have become so popular that they may become twice monthly. The brewery is booked for Bingo fundraisers through May and already has July reserved.

For bingo fundraisers, McHoppers provides all supplies; organizations only need to bring prizes and a caller.

"We want to be a big footprint in the community," McMordie said. "When people come to Fernley, we want them to say, 'You've got to go to McHoppers.'"

The brewery also recently joined Harvest Host, allowing RV travelers to dry camp in the parking lot for free while visiting the brewery. McMordie and Hopper say it's already helping spread Fernley's name to visitors from across the country.

With Fernley's population now around 26,000, the owners say they hope the expanded offerings keep more residents in town instead of driving to Reno.

"We hear all the time that there's nothing to do here," McMordie said. "There's 26,000 people in Fernley at this point, and at any event, the whole town shares 800 people. And I'm wondering where the rest are, you know? So by providing something that's out of the norm and a little bit different, maybe some of these people stay in Fernley and spend their money instead of driving to Reno."

State Treasurer encourages Nevadans to Search for unclaimed property

Staff Report

As Nevadans ring in the New Year and set financial goals for 2026, Treasurer Zach Conine is reminding Nevadans to check for unclaimed property that may belong to them.

The State of Nevada is currently holding more than \$1 billion in unclaimed property owed to Nevadans ranging from forgotten bank accounts and uncashed checks to insurance proceeds and utility deposits.

"Each new year is a fresh start, and 2026 is the perfect time for Nevadans to reclaim money they may lost along the way," said Treasurer Zach Conine. "Searching for unclaimed property is free, easy, and could put extra cash in your pocket."

Unclaimed property typically consists of financial assets that businesses are unable to return to their owners, often due to a move, name change, or outdated contact information. The State Treasury holds these funds in perpetuity and the Office's Unclaimed Property Division works to reconnect owners or their heirs with their property.

Businesses are required by law to report unclaimed property each year. When companies are unable to return funds to their rightful owners after a set period of inactivity, they must report and remit those assets to the State.

Nevadans can visit NVUP.gov to see if they have any unclaimed property owed to them.

Torres said the city is working to repair its relationship with NDOT, which he said was damaged when previous city administration threatened a building moratorium over the inadequacy of the roundabout. Last January, the council approved a resolution that exempts the roundabout from the minimum Level of Service the city requires, to allow development to continue.

"Council is not going to approve a building moratorium," he said, while acknowledging the roundabout was undersized from the beginning.

"Anybody who was here at the time knew that it was too narrow," he said.

Torres said he hopes completion of Nevada Pacific Parkway will divert a significant share of traffic away from the roundabout.

Torres noted that the Lyon County Regional Transportation Commission recently approved funding for plan-

The City wants to let residents know that FEMA Federal Emergency Management Agency has issued an update (or Letter Of Map Revision LOMR) to the flood maps for the City of Fernley.

What has changed: Certain areas along HWY 95A have been updated from a "Zone A" to "Zone AE", which now has defined flood elevations. The area on the east side has been designated Zone AO, meaning shallow flooding may occur in this area and new floodplain rules may apply.

Where can I find the data: Residents can view the revised maps at City Hall, on our City website, or by contacting the City Manager's Office.

Who to contact for help: Residents can contact the City at engineering@cityoffernley.org with questions or for assistance interpreting the maps.

Why it matters: The update affects property owners, insurance agents, and mortgage lenders, helping them understand flood risk and insurance requirements.

FAQ's About FEMA Federal Emergency Management Agency Flood Maps For the City of Fernley:

- What is FOMR?** A FEMA Federal Emergency Management Agency-issued revision to flood maps based on improved data.
- Why was it issued?** Updated hydrologic/hydraulic analyses and topography provided improved accuracy.
- Which areas are affected?** HWY 95A Ditch, HWY 95A Ditch Split, and shallow flooding near Desert Shadows Lane.
- When is it effective?** April 13, 2026.
- Can residents appeal?** Yes - within 90 days after the second newspaper notice.
- Will this change insurance requirements?** Possibly. Properties newly mapped into Special Flood Hazard Areas may require flood insurance.
- Does this affect building requirements?** Yes. New development must comply with updated floodplain regulation.

Unregistered sex offender arrested in Dayton, dies while being transported to jail

A person arrested on a charge of failing to register as a sex offender died while being transported to jail.

According to the Lyon County Sheriff's Office deputies from the Sex Offender Task Force responded to a home in the Dayton area on Dec. 31 following an anonymous tip regard-

ing a convicted sex offender who had failed to register as required by law. Members of the Task Force located and arrested the person on the charge of failure to register as a sex offender.

The person was being from the Dayton area to the Lyon County Jail for booking. While en route, the transporting deputy stopped at the Silver Springs Substation to adjust the

person's restraints. Upon arrival at the substation, the deputy discovered the person to be unresponsive.

LCSO said deputies immediately removed the person from the vehicle and initiated CPR. Central Lyon Fire personnel arrived on scene and assumed lifesaving efforts. Despite these efforts, the person was pronounced dead.

Pursuant to the Regional Critical Incident Investigation Protocol, the Carson City Sheriff's Office and the Nevada State Police, Investigations Division will conduct the investigation into the death.

The identity of the person was withheld pending notification of next of kin.

Vaqueros bounce back from tournament loss with win in league opener

Vaqueros roll past Lowry in league opener

The beginning of league play brought out the best in the Fernley Fernley High School girls basketball team. The Vaqueros scored the game's first 12 points, led by 24 at halftime and rolled to a 59-27 win over Lowry last Friday night in the first Northern 3A East game of the season.

Taylor Tollestrup led the Vaqueros with 27 points, five of her teammates have between five and seven points, the Vaqueros dominated the game from start to finish.

"The two final games at Hug we had a lot of confidence each game and I wish the games were a little closer so we could work on game situations," Dunn said.

The Vaqueros had their highest scoring game of the season against Carson, with five players in double




