Trustees give superintendent satisfactory evaluation

Lyon County School District Superintendent Tim Logan received a satisfactory evaluation for his first year on the job from the District's Board of Trustees.

Logan received a composite score of 3.66 on a scale of 1-5. A score of 3.67 would have fallen in the "exceptional" category.

While Logan has only been in his position for a year, after being hired to replace Wayne Workman, who resigned after the 2023-24 school year, three of the seven trustees have only been in office since January, and several of them said that made the evaluation process tricky.

"Our superintendent has only had one year, and he hasn't had any direction from the current board during that time," Board President Tom Hendrix said. "We did come up with a new District Performance Plan that gives him guidance as to what this board is looking for and I look forward to his implementation of that over the next year."

Trustees Elmer Bull and James-Whisler, who along with Dawn Carson were just elected last November, each said they didn't have a lot to go on in filling out the evaluation. Bull, in particular, called it "perplexing."

"I certainly had nothing to say negative about the superintendent," Bull said. "I had a few positives for sure, but I can tell you overall, I feel that he's doing a fine job, and I am really encouraged by some of the developments."

Bull and Trustee Sherry Parsons each said they are encouraged by the improved communication that seems to have resulted from a recent board workshop. Bull said he is concerned about how the district is going to address things like poor behavior by students, poor teacher retention and recruitment.

"But I do believe we're taking a shot at trying to address that and trying to figure out how to move forward on those and kind of move the dial a little bit on that," he said.

Whisler agreed with Bull that it's tough to evaluate someone you've only worked with for five or six months.

"I definitely wanted a lot of positives in there, because I think Superintendent Logan's got a great future here and can be one of the best superintendents this district's had," Whisler said.

Each trustee rated Logan on a scale of 1-5 in 32 total categories. The average score of all the categories added up

to 3.66.

An overall average between 1 to 2.32 signifies an unsatisfactory evaluation, 2.33 to 3.66 points signifies a satisfactory evaluation, and 3.67 to 5 points signifies an exceptional evaluation.

Logan credited district staff for many of the things he was credited for in the evaluation. "A lot of the stuff in the evaluation comes from their work and I do definitely appreciate them," Logan said. "Some things are quick and easy to fix, and other things are going to take some time."

NDOT presents plan for I-80 widening project

The Nevada Department of Transportation is continuing to take public comment through a virtual public meeting on the Environmental Assessment (EA) for the proposed Interstate 80 East Widening Project. proposed mitigation measures and the preferred alternative we build if the project moves ahead," Hopkins said. Senior Project Manager Chris Kuhn said there has been an approximate increase in traffic of 70% in the last 10 years.

"Obviously a lot of congestion because of that and a lot of crashes and operational issues," Kuhn said. "The goal of the project is to address those issues by adding additional capacity, reconfiguring and upgrading the interchanges and by implementing safety improvements such as widened shoulders, wrong way driver detection systems and median barrier rails." Kuhn said the preferred alternative is to expand I-80 to three lanes in each direction between Vista and USA Parkway. He said other planned improvements to the Lockwood, Mustang and Patrick interchanges would help traffic move more efficiently and safely through the area.



NDOT officials held a public hearing in Lockwood on June 25 to explain the project, but the exhibits presented at the meeting are available through July 18 at I80EastNV.com. At the June 25 meeting, NDOT Public Involvement Coordinator Justin Hopkins, said the project would expand the highway from Vista Blvd. in Sparks to USA Parkway. He said the project is being studied in accordance with the National Environmental Policy Act commonly called NEPA, to make sure all of the potential environmental impacts are being evaluated and to get input from the public before moving forward.

"We've prepared an environmental assessment that outlines the project's purpose and need, potential impacts, "If you couldn't make it to today's public hearing, no worries," Kuhn said. "You can review all of the details and submit your questions or comments online anytime." The public comment period is open 24 hours a day through 5 p.m. Friday, July 18

All ideas are welcome, and I'll be sure to keep you posted on ways you can get involved.

After 40 Years, Nevada's State Entomologist Retires

After four decades of dedicated service to the Silver State, Jeff Knight, Nevada's longtime state entomologist, is preparing to retire. His final day with the Nevada Department of Agriculture (NDA) will be Friday, July 4, 2025.

Knight's path to entomology began in childhood, sparked by an early fascination with insects and nurtured through 4-H programs. He earned a Bachelor of Science in pest management from the University of Nevada, Reno, followed by a Master of Science in entomology from Utah State University. He first joined NDA as a seasonal entomologist in 1977.

Knight has deep Nevada roots and strong ties to the Fallon community. In October 1976, he married Fallon resident Virginia Guazzini. They welcomed son Brian in 1980 and daughter Angela in 1982. He continues to spend much of his time in Fallon with family. In 1993, Knight was promoted to state entomologist, a role in which he helped safeguard Nevada's economy and food systems by leading responses to invasive species and agricultural pests. According to NDA Director J.J. Goicoechea, Knight's "passion and dedication to the development and curation of the State of Nevada Entomology Collection has catalogued the discovery of new species within the state and expanded the formal state records for species." Knight also became a go-to resource for the public and agriculture professionals alike, identifying countless specimens and offering guidance on pest management. "He has also identified innumerable samples from the public and agriculture community, offering insights and management recommendations," Goicoechea noted. Throughout his career, Knight

was known not only for his scientific expertise but also for his commitment to public education and environmental stewardship. "Jeff is regarded as a tireless advocate for environmental stewardship, educating Nevadans on the importance of sustainable practices to preserve our state's valuable ecosystems," said Goicoechea.

Knight has worked on several of Nevada's major insect issues, including Mormon crickets, fire ants, grasshoppers, gypsy moths, spiders, Japanese beetles, Africanized honeybees, and more. He has given thousands-literally-of lectures throughout Nevada and Fallon, working closely with the University of Nevada Extension Office, Master Gardeners, schools, and other organizations. He is a familiar face at the Fallon Cantaloupe Festival, often staffing the Department of Agriculture's booth, and has spent countless hours teaching students about insects in classrooms across the region.



Sharing his love for the field, Knight also taught community education classes through Western Nevada College's Fallon campus. One beetle has already been named in his honor as a newly discovered species, with another in the process.

With his July retirement approaching, colleagues across the state are taking time to reflect on Knight's many contributions to Nevada's agriculture, environment, and scientific community. Governor Joe Lombardo has issued a proclamation in his honor upon retirement.

"We wish him all the best in his well-deserved retirement," Goicoechea said.

FCTA awards \$92,125 in grant funds for community events

The Fernley Convention and Tourism Authority awarded \$92,125 in grand funding to 10 community organizations for events to promote tourism.

The Fernley Convention and Tourism Authority was established in 2011 with the objective to distribute funds from collected Transient Lodging Taxes to special event organizers to better promote tourism in Fernley. You don't have to be retired to join RPEN, as long as you've earned five years in PERS or are 50 years or older; you can join while you're still working. RPEN is working to protect the pensions of public employees who are still working or who have retired.

LOCAL GOVERNMENT Library Board recommends Ross for one board seat, no consensus on other

With the terms of two members of the Lyon County Library Board of Trustees expiring, the Trustees voted 3-1 at their June 24 meeting to recommend Sara Ross of Silver City to fill the seat representing the Dayton area but reached no consensus on a recommendation for the seat representing Silver Springs.

The terms of Trustees Kay Edwards of Stagecoach and Deanne Davis of Dayton expiring, the Trustees voted 3-1 to recommend the appointment of Ross to represent Dayton. But a motion

to recommend the appointment of Edwards for a second seat ended in a 2-2 vote, with Trustees Jan Shardt and Nora Stevens in favor, and Davis and Patti Palmer opposed. A second motion, to recommend the appointment of Vida Keller, also ended in a 2-2 vote, with Davis and Palmer in favor and Shardt and Stevens opposed. Edwards recused herself from both votes on the recommendation of District Attorney Steve Rye. Davis likewise recused herself from the vote on the motion to appoint Ross.

Following the second 2-2 vote on the Silver Springs seat, Davis asked

if anyone would like to make another motion, and none was offered. "If there's no other motion, then there would be no recommendation regarding Silver Springs," Rye said. "For the minutes and the other information, just indicate that there was not a recommendation approved."

Under County policy, the Trustees make recommendations to the Lyon County Commission to fill vacant seats, but the Commission makes the final decision. The last time there was a vacancy on the Board, the Trustees voted 3-1 to recommend the appointment of Suzanne Prouty of Fernley, but the

Commission voted to appoint Palmer. The Trustees had received six applications for the two spots, with Davis, Ross and Sara Jorgensen of Dayton applying for the seat representing Dayton, and Edwards, Keller and Eric Nelson of Stagecoach applying to represent Silver Springs.

Because the meeting happened after the cutoff to get on the agenda for the July 3 Commission meeting, Library Director Wynne Prindle told the Trustees the item would likely be placed on the agenda for the Commission's July 17 meeting.

Fernley Needs YOU!

The Lyon County Sheriff's Office takes great pride in partnering with multiple law enforcement, medical, and civilian programs within the county. One such program that the Sheriff's Office has partnered with since 2024 is Battle Born Medevac, a service of the Rural Medevac Alliance. Based out of Yerington, this privately owned company was created to better serve the citizens of Lyon County, with an emphasis on the southern portions of Silver Springs, Yerington, Mason Valley, Wellington, and Smith Valley.

This program offers emergency medical services through the primary use of a helicopter, and a ground medical transport vehicle. Battle Born Medevac began operations and were deployed by helicopter on June 19th, 2024. Since then, they have been called to serve during numerous medical emergencies, public events such as Night in the Country, and have provided stand-by emergency medical options during critical incidents in all areas of the county. Some of the many options they provide for the Deputies is an immediate response during LCSO SWAT operations, patrol critical incidents, and assisting all county Fire Protection Districts with emergency medevac call outs.

Since 2024, Battle Born Medevac has been going through an ongoing accreditation program through the National Accreditation Alliance of Medical Transport Applications (NAAMTA). During this accreditation period, they have been tested through pilot certification, both day and night flight operations, paramedic training, and have been proven to adhere to the highest standards in the air medical industry. They provide safety, professionalism, and compassionate care on every flight.

Each flight crew includes a highly trained pilot, flight nurse, and a flight paramedic that are all capable of delivering ICU-level critical care, whether at a rural clinic, hospital or on scene.

On June 11th, they successfully

completed the accreditation process and even added a second helicopter to their fleet. Many of the flight crew have 10+ years of experience in aviation, and emergency medical services. As a locally based, community-focused provider, they offer a personalized approach that sets them apart from larger models of medevac services.

The crew works in partnership with the Lyon County Sheriff's Office Dispatch Division and have even created and provided the Dispatch center with a proprietary Computer Aided Dispatching (CAD) System. This system was integrated into our Dispatch center and the flight crew has provided ongoing training and support to our Dispatch team.

The Sheriff's Office has assigned one of our Dispatch supervisors as the subject matter expert and liaison to the program. This supervisor is in charge of the day-to-day operations of the Dispatch shift and also has the responsibility of ensuring that all Battle Born Medevac training is being conducted. This includes ensuring that all rules, regulations, and policies are being adhered to, as well as doing regular audits on the calls for service which are being dispatched. This was a large undertaking for our Dispatch center as it added additional duties and responsibilities to all Dispatch team members. Our team is required to enter the medical call into the CAD system, dispatch the pilots and crew through radio, as well as continually monitor flight paths and conditions during the calls for service.

Through a new collaboration with SB Energy, all permanent residents of Lyon County are now automatically enrolled in the Rural Medevac Alliance membership with no sign up required. Any medically necessary air transports are fully covered with zero out-of-pocket costs. How City Planning Decisions Shape Fernley's Future

Fernley is one of the fastest-growing communities in Northern Nevada. With its strategic location, expanding industrial base, and strong community spirit, it stands at a crossroads where planning decisions made today will define what kind of city it becomes tomorrow.

From the location of new roads and parks to where businesses and homes are allowed to grow, city planning isn't just about maps and permits. It's about shaping opportunity, protecting quality of life, and ensuring that Fernley grows smarter, not just bigger.

What Is City Planning, and Why Does It Matter?

City planning is the process by which local governments determine how to utilize land, develop infrastructure, and deliver public services. In Fernley, these decisions are guided by two core documents:

- 1. The Master Plan A long-range plan for growth, zoning, transportation, housing, and economic development.
- 2. The Capital Improvement Plan (CIP) A rolling five-year list of infrastructure projects like water systems, roads, and public buildings.

These tools determine whether new neighborhoods have sidewalks or streetlights, whether fire stations are built near growth areas, and whether businesses have the necessary power, water, and access to thrive.

In short, Planning decisions either unlock Fernley's potential—or leave it underprepared for the challenges of growth.

Why Planning Is Urgent Now

Over the past decade, Fernley has become a magnet for industrial development and new residents. Projects like Victory Logistics District are bringing high-quality jobs, new businesses, and tax revenue. But with that growth comes pressure—on schools, roads, emergency services, and housing.

Just as critical is the need to engage residents and stakeholders early and often, making the planning process more inclusive and transparent. Thoughtful planning isn't about more red tape. It's about creating clarity, reducing friction, and building trust between the city, residents, and business community.

For many of the students, it was their first time receiving shoes that were not only new, but also fashionable and comfortable.

"They are super comfortable, so my feet don't hurt when I walk or run," one student said. "I can play tag and race my friends at recess without slipping or getting tired."

Beyond the joy of receiving new shoes, this donation has allowed LCSD to reallocate resources, such as clothing support and funding for extracurriculars, to continue to meet the diverse and growing needs of homeless youth.
